### **Product Description**

Light beige, liquid heavy-duty hand cleanser with skin-neutral pH value, solvent-free, perfumed or perfume- and fragrance-free

#### **Product Properties**

ULTIMO is a hand cleanser for the removal of medium dirt. Although the product has a strong cleansing effect, the skin is not affected by abrasive scrubbing agents. According to the pH value of the human skin, the liquid heavy-duty hand cleanser is slightly acidic. The dermatological compatibility of the mild surfactant combination with acyl glutamate in combination with lipid-replenishing glycerol esters is very good. ULTIMO contains the patent-registered dirt removing agent ULTIMO made of hydrogenated castor oil (wax) can remove dirt particles without affecting the skin. Furthermore, there are no residues in traps and sewers. ULTIMO is also available as perfume- and fragrance-free version which is HACCP-compliant and can be used safely for personal hygiene in the food industry in consideration of the respective application instructions

# **Composition according to INCI**

AQUA, HYDROGENATED CASTOR OIL, COCO-GLUCOSIDE, GLYCERIN, BRASSICA CAMPESTRIS SEED OIL, SODIUM COCO-SULFATE, OLEIC ACID, SODIUM CHLORIDE, MAG-NESIUM STEARATE, GLYCERYLOLEATE, SODIUM BENZO-ATE, POTASSIUM SORBATE, XANTHAN GUM, CITRIC ACID, (PARFUM)

### **Application**

Apply ULTIMO evenly on the dry skin. For medium dirt, a small hazelnut-sized amount of the hand cleanser is sufficient. Rinse off with plenty of water afterwards and dry hands thoroughly. A proportional bigger amount of the hand cleanser has to be used in order to remove heavier dirt.

### **Certificate of Dermatological Compatibility**

The dermatological compatibility of REGENT ULTIMO has been carefully tested and proven. A printed certificate is available.

The surfactants used fulfill the requirements of easy biological degradability as they are determined in the Regulation (EC) No 648/2004 on detergents. The laboratory testing of surfactants in the context of this regulation is based on the "Confirmatory Test" procedure of the OECD method.

## **Statutory Regulations**

REGENT ULTIMO is subject to the Regulation (EC) No 1223/2009 on cosmetic products. Further details on handling the product can be obtained from the Group Data Sheets for skin products (for occupational use).

#### **Storage Instructions**

The product will keep for at least 30 months (from date of manufacture) if stored unopened at room temperature in the original packaging. The Period After Opening (PAO) is indicated on each tube / bottle / canister.
